Priestfield Parish Church of Scotland, Edinburgh Trustees' Report Year ended 31 December 2022

The Trustees present their annual report and financial statements of the charity for the year ended 31 December 2022. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the General Assembly Regulations for Congregational Finance, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland effective 1 January 2019.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

The congregation's priorities flow from its own consideration of its calling and are set out in the congregation's Local Church Review. The current Review, which was updated comprehensively during 2019, sets out the following priorities:

- 1. Work with our neighbouring congregations in mission across the area.
- 2. Engage with the diverse needs of the local parish community in ways appropriate to their settings.
- 3. Reach out to the student population in the parish and support those we are in contact with.
- 4. Make disciples.
- 5. Introduce a new Pastoral Care scheme.
- 6. Maintain and enhance the fabric assets of the congregation and church to maximise their missional value.

After two very difficult years, when COVID impacted on the life of the congregation with closures and ever-changing regulation, 2022 has been marked by a slow return to a new normality. The year began with the resurgence of the virus in the form of the Omicron variant. By this time though the use of vaccines reduced the impact and this led to the relaxation of most mandatory control measures by the Government during Spring 2022.

Congregational life slowly got back to a regular pattern. Sunday worship returned to a regular rhythm week by week.

Most congregational groups have returned; Praise and Prayer meets fortnightly again and the choir has returned to practise and share in leading Sunday worship.

During the course of the year the Priestfield Guild joined with other local Guilds to form a new Southside Guild.

Most third party 'tenants' of the church buildings have now returned to operate within the church building.

Since the introduction of the first lockdown in 2019 Priestfield had put significant resources into reaching its community on-line rather than face-to-face in the building. Initially we had used pre-recorded material posted on-line in time for Sunday morning but in the latter part of 2021 a suite of technology to permit streaming of composite real-time and recorded material was installed. 2022 was the first full year of the operation of the new facility and following training a team now operates the equipment with increased sophistication.

The Church, and particularly the Minister, supports those that are bereaved, whether members or not, with both personal support and formal funeral arrangements.

Priestfield Church has provided a home for the Edinburgh Korean Church for many years. The Korean fellowship did not meet in the building for the duration of the COVID 19 pandemic but returned in August 2021, albeit with a smaller congregation.

The Church Hall (Whithorn) and ancillary rooms are used by the various sections of the Scout and Guide groups, which cater for children and young people across a wide age-range. Following relaxation of controls, most groups returned to meet in Whithorn in late summer 2021 and have continued to meet 'normally' throughout 2022.

The Church has robust links with Prestonfield Primary School. Links were maintained during the course of year with the minister visiting regularly to take part in school assemblies and to provide general support.

Our Mission Development Worker, Michael McMullin, worked across the three existing parishes of Craigmillar Park, Priestfield and Reid Memorial Churches. Michael resigned during the summer to follow a leading to become a Minister of Word and Sacrament.

In the last two weeks of December 2021, Edinburgh and West Lothian Presbytery published revised proposals for consultation. These proposals have a single new parish comprising the existing parishes of Craigmillar Park, Mayfield Salisbury and Priestfield within a Central Mission District (or Cluster). Presbytery also undertook an Asset Management Building Audit (AMBA) to assess buildings and feed into the planning process.

Following a sustained consultation, Presbytery approved a final Plan on 15 November 2022. The proposed new parish of three existing local congregations was included in this approved Plan.

The proposed new parish would have two Ministers of Word and Sacrament, one of whom would be a Pioneer Minister.

The Plan indicates that Mayfield Salisbury is an excellent complex for mission and should be designated 'A' for retention. Craigmillar Park and Priestfield are relatively close and thus retaining both may not be the best use of missional resources. The Plan proposed that both Craigmillar Park and Priestfield be designated 'B' for disposal in order to begin careful consideration regarding not just 'the well-equipped space in the right place' but mission. A choice should be made by 30 June 2024, with a release date of 30 June 2025, at which time an annual review can designate the other 'A' as appropriate.

At the close of the year discussions commenced across the three congregations on moving towards the proposed union. In December the approved Plan was presented at a meeting of the congregation.

Achievements and Performance

Formal membership at the close of 2022 stood at 98 compared with 99 at the start of the year.

In the first months of 2020, prior to the pandemic, attendance at Sunday worship averaged 71. After the re-opening, by July/August 2021 average attendance stood at 32 and by October/November average attendance had risen to 48. This has risen slowly during the course of 2022 with attendance generally being between 55 and 60.

In parallel with this in-person congregation, the investment of money, time and effort into on-line services has given rise to a new on-line congregation. This is difficult to quantify for a number of reasons but each week between 65-150 people have 'looked in' at the service. The furthest away has been New Zealand, regulars from Australia, Canada and the United States with occasional visitors from Malawi, South Africa and Kenya, and regulars from various parts of the UK.

The pastoral support network, 'Priestfield Link Up', operates across the broader congregation; members, friends and associates. A team of twenty keep in contact with over 120 people and provide support when appropriate.

'Praise and Prayer' times moved back into the building 'in-person' at the beginning of September 2021. The fortnightly prayer sheets continue to be posted on the church Facebook page to support the on-line church community.

Messy Church moved back into the building in December 2021. In 2022 Messy Church was held in February, April, May, September, October, November and a Christingle time on Christmas Eve. Attendance has returned to nearly fifty and consideration is being given to having an additional Messy Church in January.

Priestfield's Minister and successive Head Teachers at Prestonfield Primary School have enjoyed an excellent working relationship.

During the course of the year maintenance of the school garden has been undertaken by a group of friends from the local allotments who were 'invited' to do so by Priestfield's minister. Our minister is often in school and each child in the school and nursery was given an Advent calendar and booklet with the Christmas story. Contributions towards the cost came from both Craigmillar Park and Mayfield Salisbury Churches.

Towards the end of the year, as the cost-of-living crisis began to bite, a useful informal referral link was set up between school and church to enable practical assistance to be given to those in very real need. To support this the church set up a 'Hardship Fund' with local funds. An application for a grant was also made to the Corra Foundation and at the year's end a decision was awaited.

Also, to provide assistance for those people struggling with energy costs, in December the church Lounge was opened as a 'Warm Space' every Thursday afternoon. This is part of a local network.

Other community-based 'services' included an Act of Remembrance and the Christmas tree lights switch-on and carol singing, both at the Memorial Garden, Prestonfield Avenue.

Reflecting the Presbytery Plan and recognising that any successful union will depend upon the development of relationships across the three existing congregations, a series of 'shared services' was arranged in each other's churches. This positive start will be developed further in 2023.

The congregation continued to give financial help and support to a number of charities.

Christian Aid

In 2022 we adopted again the pattern developed during 2021. Envelopes were distributed house-to-house across areas in the parish with donors being invited to return their gifts to various church access points. The use of 'e-envelopes' and direct giving via the Christian Aid website were also publicised. The May Café Time was used to raise further funds for Christian Aid and church members took part in a fun charity walk around the '7 Hills of Edinburgh.' In total over £3,400 was raised for Christian Aid during the course of 2022.

Bethany Christian Trust

In 2022 the Bethany Care Van continued to be well supported by members of Priestfield.

Blythswood Care

In 2022 the congregation again contributed to Blythswood Care's Shoe Box Appeal. Members of the congregation filled shoe boxes with basic essentials, things we take for granted but which can be luxuries for people living in desperate poverty. Despite the considerable difficulties, 26 boxes were filled and donated.

and there was continued support for Just Trading Scotland (JTS).

The congregation also supports wider mission via its 'Giving to Grow' contributions to the Church of Scotland.

In normal times there is continued heavy use of the church buildings in a way that serves the broader community. A wide variety of church, community interest and support groups use the premises. This was not possible during the peaks of the pandemic when gatherings were prohibited or severely constrained by government regulation.

With the relaxation of controls most groups have now returned to use the church buildings, with appropriate mitigations in place. Interestingly the church accommodation is under increased pressure, especially from choirs and other performing groups. This reflects the restricted availability of community and university accommodation.

As a sign of returning to normality at Christmas the opportunity was taken to again distribute gifts 'without strings' as blessings across the local community. Members gave tins of chocolates or biscuits and cards to groups of employees at locations throughout the parish area; care homes and supported accommodation, the Royal Mail Sorting Office, Recycling Centre, school, nursery, shops, etc. A total of twenty-six 'blessings' were distributed in this way.

Although it was not possible to arrange an 'Angel Trail' at Cameron Toll in 2021, we were able in early December, with our friends at Newington Churches Together and led by the Salvation Army band, to come together for carol singing at Nicolson Square Garden.

Continuing the development of a Christmas Angel theme, the angels which had been knitted by ladies of Priestfield and Craigmillar Park and Mayfield Salisbury Churches were given away free to local people passing by the church. 160 angels were given away to the local community.

Priestfield also hosts and helps staff CAMEO (Come And Meet Each Other), in partnership with Friends International, a meeting place for international women who are either students or the wives of students and their pre-school children. Activities include aspects of British/Scottish culture, presentations from members about their culture and customs, games, crafts and outings. Meetings which include food or country dancing are always very popular. The Group held two whole-family events - a summer picnic in the church garden and a Christmas party in the hall. A spin-off bible study class operated in the spring and an English conversation class has now started, both set up by members with support from the Cameo team. Membership of the group changes as students finish their courses. During the course of the year countries represented included Hong Kong, Taiwan, China, Palestine, Yemen, Afghanistan, Indonesia and South Korea.

2022 saw much reliance on the Church's Facebook page to communicate and as a point of contact and reference. The platform has been used to provide day-to-day information and importantly for posting all services and meditations as well as regular prayer material. This has proved useful in reaching people beyond the normal congregational circle.

The congregation continues to implement physical projects to maintain its buildings and develop them for its mission. During 2022 the following work was completed;

- Renewal of the church fire alarm system
- Replacement of the heaters in the church Lounge
- Redecorating the manse lounge
- Roof repairs at the manse

Financial Review

We are pleased to report that despite a fall in Unrestricted Income from £96,719 in 2021 to £91,426 we managed to end the year 2022 with a surplus of £14,483. The costs for the year were held to £76,943 compared with £75,949 in 2021.

Our main Restricted Funds were a Grant of £1,554 from the Church of Scotland Winter Grant to improve the heating in the Lounge and an Anonymous Donation of £2,000 to a Hardship Fund to help people in the neighbourhood suffering from the inflationary problems of this winter.

The final balance of the loan from the Church of Scotland of £3,000 was repaid in March 2022.

As before we trust that members will continue to review their giving prayerfully in order to support our missional objectives both within our building and beyond it.

Risk Management

The Presbytery Plan requires only final approvals. This Plan sets out the future shape of the church in Edinburgh and West Lothian. The most significant change in the life of the congregation is now set with Priestfield joining Craigmillar Park and Mayfield Salisbury in a single new parish.

This presents exciting opportunities, a once in a lifetime opportunity to shape the local church so that it is fit for purpose for the coming years; that is fit and equipped for mission and service to the local community. The Trustees will require to have a clear vision for the future and be ready to work hard for it as necessary.

It will also be crucially important to keep the existing Priestfield congregation informed and involved as the union process progresses. This process will need to develop and maintain support and a shared vision for the future.

Reserves Policy

In accordance with the Trustees' agreed policy of holding Reserves we can report that at 31st December 2022 we had enough Unrestricted Funds to meet over 8 months normal expenditure.

Structure, Governance and Management

The congregation is a registered charity, number SC014499, and is administered in accordance with the terms of the Deed of Constitution (Unitary Form) and is subject to the Acts and Regulations of the General Assembly of the Church of Scotland.

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. Certain responsibilities are delegated to the Finance, Mission, Student Link and Property Groups, as appropriate. The Kirk Session, which has six scheduled 'ordinary' meetings a year, is responsible for spiritual affairs within the church.

Accounting Policies

The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) issued on 16 July 2014 and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

Fund accounting

Funds are classified as either restricted funds or unrestricted funds, defined as follows.

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the charity.

Endowment funds are funds which have been given on the condition that the original capital sum is not reduced, but the income there from is used for the purpose defined in accordance with the objects of the charity. We have no endowment funds.

Unrestricted funds are expendable at the discretion of the trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the trustees' discretion to apply the fund.

Incoming resources

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received, and the amount can be measured reliably.

Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102) the general volunteer time of congregation members is not recognised.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised as expenditure in the period of receipt.

Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

Fixed Assets

The charity has the right to occupy and use for its charitable objects certain tangible fixed assets, including the Church, halls and manse, vested in the Church of Scotland General Trustees. No consideration is payable for the use of these assets. Expenditure incurred on the repair and maintenance of these assets is charged as resources expended in the Statement of Financial Activities in the period in which the liability arises.

Tangible Fixed Assets

There are no tangible fixed assets.

Investments

There are no Investments.

Taxation

Priestfield Parish Church is recognised as a charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its charitable activities. The charity is not registered for VAT and resources expended therefore include irrecoverable input VAT.

Loans – In November 2016 the congregation received a loan of £30,000 from the Church of Scotland General Trustees to enable them to go ahead with the renewal of the heating installation.
